5.2 Committee Concerns from February 4, 2015 Meeting

- Cracks in the new tennis courts.
 - o Letter from Ruhnau, Ruhnau & Clarke Architects
 - Joe Ledesma has visited the courts with tennis court experts. A contractor is proposing a fix for center court and to re-patch discolored areas.
 Experts say outer cracks are normal within tolerance of the concrete.
 Goal is to complete fix this summer
- Cameras at the concession stand.
 - The \$2,567.81 left in Measure "R" funds will be applied to this Purchase Order. The remainder of the cost is budgeted for 2015/2016. Cameras will be ordered and installed after July 1, 2015 to keep work and receipt of merchandise in same fiscal year as payment.

5.3 Equipment for Concession Stand

Equipment was successfully installed as of May 20, 2015. A curb platform and roof jack had to be built on the roof before the ice machine's condensing coil unit could be installed. The District's maintenance staff built them (see Work Order #51488).
