

RESOLUTION NO. 06-07-20

RESOLUTION OF THE BOARD OF TRUSTEES OF THE BANNING UNIFIED SCHOOL DISTRICT CERTIFYING TO THE BOARD OF SUPERVISORS OF RIVERSIDE COUNTY ALL PROCEEDINGS IN THE NOVEMBER 7, 2006, GENERAL OBLIGATION BOND ELECTION CONDUCTED WITHIN THE BANNING UNIFIED SCHOOL DISTRICT AND MAKING RELATED FINDINGS

WHEREAS, the Board of Trustees of the Banning Unified School District ("Board of Trustees"), County of Riverside ("County"), State of California, previously adopted its Resolution No. 06-07-02, ordering the County Registrar of Voters to call an election for general obligation bonds (designated as "Measure R") ("Bond Election") to be held on November 7, 2006; and

WHEREAS, the Bond Election was called pursuant to the provisions of the California Constitution and State law, including, but not limited to, the terms and conditions of the "Safer Schools, Smaller Classes and Financial Accountability Act," also known as "Proposition 39" and related State legislation; and

WHEREAS, Resolution No. 06-07-02, was duly delivered to the County Clerk and County Registrar of Voters; and

WHEREAS, notice of the Bond Election was duly given; and

WHEREAS, on November 7, 2006, the Bond Election was duly held and conducted for the purpose of voting on a measure for the authorization of the issuance of bonds of the Banning Unified School District in an amount not to exceed \$63,00,000 ("Bond Measure"); and

WHEREAS, the Board of Trustees has received from the County Registrar of Voters Office the Canvass and Statement of Results of the Bond Election ("Certificate of Election"); and

WHEREAS, it appears from the Certificate of Election, a copy of which is attached hereto as Exhibit "A," and incorporated herein by this reference, that fifty-five percent (55%) or more of the votes cast on the Bond Measure as part of the Bond Election were in favor of the proposed Bond Measure.

NOW, THEREFORE, THE BOARD OF TRUSTEES OF THE BANNING UNIFIED SCHOOL DISTRICT DOES HEREBY RESOLVE, FIND, DETERMINE AND CERTIFY AS FOLLOWS:


Section 1. That entry be made upon the minutes of this meeting that the Bond Measure has been approved by fifty-five percent (55%) or more of the votes cast at the Bond Election.

Section 2. That all proceedings of the Banning Unified School District in connection with the November 7, 2006, Bond Election have been accomplished according to law.


Section 3. That the Clerk of the Board of Trustees is hereby requested to deliver, or arrange for delivery of, a copy of this Resolution to the County Superintendent of Schools and to the Clerk of the Board of Supervisors of the County.





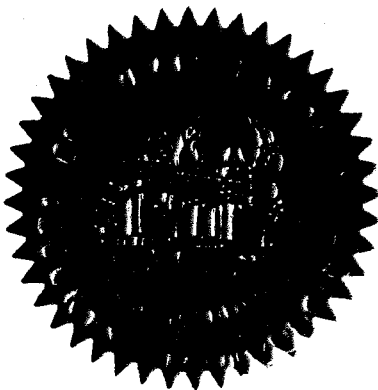
